Benefits of Locating in the Dayton Region

Connectivity

You won't find better connectivity to the United States anywhere else. The Dayton region is strategically located at the intersection of Interstate 70 and Interstate 75. This provides an excellent location for your business due to existing infrastructure and our proximity to your customers and supply chain.

The Dayton Region is located within 600 miles (966 kilometers) of:

- 61% of the U.S. population
- 63% of all U.S. manufacturers
- 70% of all North American manufacturers
- 80% of all U.S. corporate manufacturers



The Dayton International Airport (DAY) is a commercial and freight airport located 15 minutes from downtown Dayton and has flights to Newark Liberty International Airport (EWR) in New Jersey and Dulles International Airport (IAD) in Washington D.C. that connect to Tel Aviv, Israel (TLV) via United Airlines.

Additionally, the Dayton region is located in the Eastern Time Zone of the United States, which is the same time zone as New York, Boston, and Miami, and only 7 hours behind Israel. This makes it easier to conduct business within the same business day.

Wilmington Air Park (ILN) in Wilmington, Ohio is a freight only airport that is 40 miles (64 kilometers) and a 50-minute drive southeast from Dayton.

Cincinnati/Northern Kentucky International Airport (CVG) in Cincinnati, Ohio is a commercial and freight airport that is 76 miles (122 kilometers) south from Dayton along Interstate 75. CVG has flights to Toronto Pearson International Airport (YYZ) that connect to Tel Aviv (TLV) via Delta, Air Canada, and EL AL.

John Glenn Columbus International Airport (CMH) in Columbus, Ohio is a commercial and freight airport located 76 miles (122 kilometers) east of Dayton along Interstate 70. The

Columbus Airport has flights to Toronto Pearson International Airport (YYZ) that connect to Tel Aviv (TLV) via Air Canada and EL AL. Rickenbacker International Airport (LCK) is another freight only airport also located in Columbus, just 1 hour and 20 minutes east of Dayton.

Montgomery County also has access to CSX Transportation and Norfolk Southern railroads and is only 25 miles (40 kilometers) from Springfield, Ohio which has access to the Genesee & Wyoming Railroad.

The Port of Cincinnati in Cincinnati, Ohio is 50 miles (80 kilometers) south of Montgomery County, and the Port of Toledo is 150 miles (241 kilometers) north of Montgomery County if you need to move products by boat.

DRITA - Dayton Region Israel Trade Alliance

Wright-Patterson Air Force Base

Dayton is home to Wright-Patterson Air Force Base (27,000+ employees) and the Air Force Research Laboratory (\$4.5B USD annually), providing unsurpassed opportunities in Homeland Security, Defense, and Aerospace technologies. Wright-Patterson Air Force Base (WPAFB) is the State of Ohio's largest single-site employer and represents an enormous regional asset that drives Dayton's economic growth. An economic impact analysis conducted by the Dayton Development Coalition in early 2019 found that Wright-Patterson Air Force Base, the Springfield Air National Guard Base, and the Dayton Veterans Administration Medical Center have a combined annual economic impact of almost \$17 billion on the 14-county Dayton Region and generate more than 88,000 jobs.

WPAFB includes three major components:

Air Force Materiel Command

Created in 1992 and headquartered at WPAFB, Air Force Materiel Command (AFMC) conducts research, development, test and evaluation, and provides acquisition management services and logistics support necessary to keep Air Force weapons systems ready to act. 
People

The total population covered in the 14-county Dayton region is 1,274,903. The median age is 39.5.

Income and Spending

Households in the region earn a median yearly income of \$56,000. 34% of the households earn more than the national average each year. Household expenditures average \$57,000 per year.

Educational Attainment

There are over 50 higher education institutions within a 60-mile (97 kilometer) radius of

Dayton that produced almost 3,000 engineering graduates between 2016 and 2017. These institutions include the University of Dayton, Wright State University, Sinclair Community College, Clark State Community College, Miami University of Ohio, the University of Cincinnati, Xavier University, and many more.

Labor Force

The Dayton regional total labor force includes of over 643,000 people – 37% are “blue collar” workers and 62% are “white collar” workers.




The Dayton region has an above-average concentration, or “Location Quotient,” of engineers compared to other occupations in the region, or compared to other metropolitan areas. Location Quotient is a way of quantifying how concentrated a particular industry, occupation, or demographic group is in a region as compared to the nation. The Dayton region has an above average Location Quotient for Engineers, meaning there is a high concentration of those occupations in our region, especially compared to the national average and some larger metropolitan areas, all while having a median hourly earning near the national average.

In 2015, Forbes Magazine ranked Dayton as the number 10 city in the United States for Engineers based on the size of the engineering industry, annual mean salary, and gross rental rates.

Cost of Living

Affordability

The Dayton Region consistently tops national lists as one of the most affordable places to live in the country. Dayton's cost of living is seven percent below the national average. Cost of Living Comparison

The chart below compares the cost of living in Dayton, Ohio to other major metropolitan areas you may be familiar with, and the United States national average. These numbers show that your money will go further in Dayton than other areas, allowing you to keep the cost of operating your business lower as you develop and grow your U.S. venture.

- If you pay an employee \$100,000 in New York (Manhattan), New York, a comparable wage for Dayton, Ohio would be \$36,787. This is a cost savings on average of \$63,213 per employee.
- If you pay an employee \$100,000 in Miami, Florida, a comparable wage for Dayton, Ohio would be \$78,694. This is a cost savings on average of \$21,306 per employee.
- If you pay an employee \$100,000 in Chicago, Illinois, a comparable wage for Dayton, Ohio would be \$74,290. This is a cost savings on average of \$25,710.

- If you pay an employee \$100,000 in Boston, Massachusetts, a comparable wage for Dayton, Ohio would be \$60,985. This is a cost savings on average of \$39,015 per employee.
- If you pay an employee \$100,000 in San Francisco, California, a comparable wage for Dayton, Ohio would be \$46,568. This is a cost savings on average of \$53,432 per employee.

Taxes

Understanding the U.S. tax system is important for any business planning to start an operation. The information below is intended to give you a better idea of how the system is structured. As you move forward, you may want to hire an accountant to give you a better picture of the impact for your specific business.

Federal Taxes

Federal Income Tax Bracket

Income tax is a tax on the income of an individual or household. The federal individual income tax has seven tax rates ranging from 10 percent to 37 percent. The rates apply to taxable income—adjusted gross income minus either the standard deduction or allowable itemized deductions.

State of Ohio Taxes

The State of Ohio has a business-friendly tax climate that is one of the lowest in the Midwest. To create a pro-business climate, Ohio has no taxes on:

- Corporate Profits
- Inventory
- Tangible personal property
- R&D investments
- Products sold to customers outside Ohio

Ohio does have a Commercial Activity Tax (CAT) which is a single low rate of 0.26% on all in-state sales. It is measured by taxable gross receipts from most business activities.

State of Ohio Income Tax Bracket

Ohio imposes a personal income tax on individuals residing in the State of Ohio, earning or receiving income in Ohio. Everyone with federal adjusted gross income must file income tax return with the State of Ohio. This is a progressive tax bracket based on the amount of taxable income gained over the year and ranges from 0 – 5%.

Municipal Income Tax

Municipal income tax is collected by the local municipality and varies based on where a person lives and works. This usually ranges from 0 – 2.5% in Ohio.

Sales Tax

This tax is added on to the sale price of an item at the point of sale and can vary depending on where you are purchasing goods. Sales taxes are used to fund a wide variety of government services.

For example: The sales tax in Montgomery County is 7.5%. If you purchased a \$100 item, the total cost of the item at the point of sale would be \$107.50. Of the 7.5% sales tax in Montgomery County, 5.75% of this goes to the State of Ohio, 1.25% goes to Montgomery County, and 0.5% goes to the Greater Dayton Regional Transit Authority (public transportation system).

Incentives and Assistance

State of Ohio, regional, and local partners have numerous incentive programs and financing products to assist companies with Economic Development projects. Our team works with companies, large and small, to make connections, locate potential sites and buildings, identify eligible project costs, and work with companies to identify which incentives or assistance are appropriate for each project.

Workforce Assistance

Depending on where you decide to locate your business, different types of assistance are available to help you identify and train a skilled workforce to suit your business' needs. Workforce assistance can range from employee assessment and recruitment to hiring benefits for certain eligible workers, or on-the-job training to offset your costs.

DRITA is also able to provide labor market information and wages comparisons for potential positions to see what the pay for a specific job would be in the Dayton region versus other metropolitan areas you may be considering. This information makes sure companies are paying a competitive wage for employees.

Relocation Program

Relocation Program, www.makedaytonregionhome.com, is a great resource for people considering relocation to the Dayton Region, offering an overview of the area and its various services. Relocation experts will assess the needs of your prospective candidates, or current employees, and highlight what matters to them most in the Dayton region, from schools, housing, recreation, to nightlife and more. This helps calm some of the risk in employees, potential candidates, or companies who are unfamiliar with Dayton to learn about all the fantastic amenities that the region has to offer.

State of Ohio Incentives

The State of Ohio offers performance-based incentives to assist companies that are starting, relocating or expanding operations within the state. Funding decisions are based on several project factors, including, but not limited to, job creation, payroll amount, fixed-asset investment commitment, project location and project return on investment.

Local and Regional Incentives

Incentives vary between states, regions, counties, and cities. It is important to work closely with local representatives to see which programs are best suited for your potential project. These types of local incentives can range from grants for capital improvements, sales tax exemption, tax increment financing (TIF), property tax abatement, utility and infrastructure assistance, or more.

We have attached a table that outlines many of the opportunities available depending on where you may locate, and the nature of your business. Companies large and small have utilized these incentive and assistance services.
